Completed applications must be received by 5:00 PM (CST), Friday, November 14, 2025.  
We will notify all applicants of our decisions and award grants by early January 2026.

Grantees agree to submit photos with captions. Additionally, grantees are asked to publicize information about the grant received by including an appropriate description in the organization's print or electronic publications, such as an annual report. We also ask that all grant recipients share the good news using social media whenever possible.

Grantees will be invited to RLC on Sunday, March 1, 2026 to share stories and information with our congregation and community as part of our 4<sup>th</sup> Annual Mission Endowment Fund.

Organizations must be a recognized 501(c)(3) in good standing or a ministry of a congregation of the Evangelical Lutheran Church in America.

**INSTRUCTIONS:**

1. Complete and sign the Application Cover Sheet.
2. In **about 1 page**, describe the program or project for which this grant will be used, including:
  - A description of the project and its goals,
  - The community your project is trying to impact and its location,
  - The needs or opportunities to be addressed,
  - The specific outcomes that are expected to occur as a result of this grant.
3. Provide a project and organizational budget overview. The budgets should differentiate between funds that are committed and those that may come from potential funding sources.
4. You may provide supporting materials (photos, articles, letters of support) if you believe it will strengthen your application. This is optional.
5. Submit application electronically to [office@rlclakeview.com](mailto:office@rlclakeview.com) in as few attachments as possible.
6. **Completed applications must be received by 5:00 PM (CST) November 14, 2025.**
